NOTICE INVITING TENDER FROM RVSF

Reference this office Memo No. DMJ/MT/2026/49-59 dated 19/02/2026, a Notice was inviting tender to the auction of 03 (three) nos. of Departmental LMVs and 14 (fourteen) nos. of Motor Cycles from the interested Registered Vehicle Scrapping Facility (RVSF) which falls under the category of "End of Life" vehicles on 11/03/2026. The time of submission of tender has been extended to another 7(seven) days i.e on 18/03/2026 at 1200 hrs and will be opened on same day at 1500 hrs.

The condemned vehicles for auction sale are kept at M.T Branch, Tulshibari, Dhemaji and will be made available for inspection during office hours or in working day in liaising with Motor Transport Officer, Dhemaji.

The tender quotation should sealed affixing court fee of Rs. 8.25 /- (Rupees eight and twenty five paise) only and it must be accompanied by earnest money of Rs. 10.000/- (Rupees ten thousand) only for all the total condemned vehicles and motor cycles in the form of KVP/NSC/Bankers Cheque/Bank Draft duly pledged in favour of the Senior Superintendent of Police, Dhemaji, Assam failing which tender will be rejected. No cheque or cash will be accepted as earnest money. The earnest money will be returned to the bidder after attaining auction of the condemned motor cycles and vehicles.

The rate should be quoted clearly both in figures and words for (i) 03 (Three) nos. of LMV and (ii) 14 (Fourteen) nos. of motor cycle separately for each one and in en-bloc. The sealed cover containing the quotation should be superscripted with the words "Tender for (i) 03 (Three) nos. of LMVs and (ii) 14 (Fourteen) nos. of Motor Cycles".

The highest bidder shall have to deposit the sale proceeds money within 3 days to the undersigned before lifting the condemned vehicles. He/She will have to pick up the condemned vehicles within 7 (seven) days from the M.T. Branch, Dhemaji. The weight calculation and lifting charge will be borne by the selected bidder. In the event of being unable to lift the entire condemned vehicles by the 1st bidder in time, the undersigned will have the right to forfeit the earnest money in whole or in parts and cancellation of the contract without any prior notice to the defaulting bidder and in this regard, the 2nd and then the 3rd highest bidder will be given the option to lift the vehicles.


The undersigned reserves the right to accept or reject all the quotations without assigning any reason thereof.
