The District Development Committee (DDC) meeting presided over by Shri Aroop Pathak, ACS, District Development Commissioner, Dhemaji, held on 22nd July/2022 at the Conference hall, O/O Deputy Commissioner Dhemaji. The Chair welcomed all the members present in the house and started the meeting by reviewing department wise progress report submitted by the departments.

The Chairs had detailed discussion on each and every government schemes and project implemented by the concerned department with the help of PPT by the respective Head of Departments. The discussion and deliberation have summed up the following points.
